**RESOLUTION (NUNC PRO TUNC)**

On April 22, 2016, the Puerto Rico Energy Commission ("Commission") issued a Resolution and Order setting forth the procedural timetable applicable to the Commission's evaluation of the Verified Petition for Restructuring Order ("Petition") filed by the Puerto Rico Electric Power Authority Revitalization Corporation ("Corporation") on April 7, 2016.

On said occasion, the Commission provided that the Public Comments Hearing would be held on May 30, 2016. However, given that Memorial Day is held on May 30, 2016, the Public Comments Hearing shall be held on **May 31, 2016 at 9:00 a.m.** As such, the procedural timetable as amended by this Resolution will be the following:


Corporation shall also file with the Commission a copy of the published public notices within three (3) days from the date they are published.
