**RESOLUTION**

On April 1st, 2016 **HSEA PR Isla Solar III, LLC** (HSEA) filled a Request for Certification as an Electric Service Company (Request), pursuant to Regulation 8701, Amendment of Regulation 8618 on Certification, Annual Fees, and Operational Plans for Electric Service Providers in Puerto Rico (Regulation No. 8618). In its application HSEA requested some documents and information to be kept confidential, pursuant to Section 6.15 of the Puerto Rico Energy and Transformation and Relief Act, as amended, and Section 1.15 of Regulation No. 8618.

Specifically, HSEA requested that the information regarding charges and rates included in Annex B of the Request be kept confidential. They argue that as a privately held company, the business terms between HSEA and its clients are confidential and not publically available. They also argued that disclosure of such information could result in harm to future negotiations with prospective or potential clients, and cause economic harm to the Company.<sup>1</sup>

After evaluating HSEA request for confidentiality treatment of the information related to charges and rates of the company, the Commission **GRANTS** the company's petition.




