
**RESOLUTION**

On October 27, 2016, **SunEdison Puerto Rico, LLC** ("SunEdison") filed the Gross Revenue and Financial Statements for its company for Fiscal Year 2015, pursuant to the requirements of Regulation No. 8701.<sup>1</sup> As part of its filing, SunEdison reiterates its request for confidentiality regarding the financial information on its gross revenues filed with the Commission on May 9, 2016.

The Commission had previously issued a Resolution, on September 29, 2016, in which it granted confidential treatment for the Information on the company's gross revenue.<sup>2</sup> Due to the fact that the information provided on October 27, 2016 is an update of information already classified by the Commission as confidential, the Commission **GRANTS** the confidentiality request made by SunEdison.
