Extend Due Date of Remaining Items.

**RESOLUTION AND ORDER**

On June 22, 2018, the Puerto Rico Energy Bureau ("Energy Bureau") issued a Resolution and Order Establishing the Calendar for Submission of Information ("June 22 Resolution and Order") in the instant proceeding. On August 16, 2018, the Energy Bureau granted the Puerto Rico Electric Power Authority ("PREPA") its request to extend the deadline for the remaining information requirements<sup>1</sup> until August 31, 2018. On August 31, 2018, PREPA requested the Energy Bureau to extend the deadline a second time. In support of its request, PREPA argued that, since it has not received an approved budget from the Fiscal Oversight and Management Board, PREPA is not in a position to develop and provide the required information.

Upon reviewing PREPA's request, the Energy Bureau **GRANTS** the requested extension and **ORDERS** PREPA to file the remaining information **on or before September 17, 2018**.
