RESOLUTION

On November 28, 2018, the Puerto Rico Energy Bureau (“Energy Bureau”) issued a Final Resolution and Order in the instant case, through which it reaffirmed the confidential nature of certain documents filed by the Puerto Rico Electric Power Authority. On November 30, 2018, the Institute for Competitiveness and Economic Sustainability of Puerto Rico (ICSE-PR) filed a document titled *Motion for Reconsideration* (“Motion”). In its Motion, ICSE-PR requested the Energy Bureau to reconsider the aforementioned confidential determination.

Through this Resolution, the Energy Bureau agreed to consider ICSE-PR’s Motion in accordance with the provisions of Section 3.15 of Act 38-2017.¹
