SUBJECT: DEFICIENCIES IN IRP FILING

ORDER REGARDING REQUEST OF EXTENSION OF TIME

After conducting a preliminary assessment of the Integrated Resource Plan (IRP) filed on July 7 and July 10, 2015 by the Puerto Rico Electric Power Authority (PREPA), the Puerto Rico Energy Commission (Commission) identified several deficiencies whose corrections are fundamental to the IRP. On August 3, 2015 we ordered PREPA to correct the identified deficiencies and to submit the corrections as part of the updated IRP, to be filed on August 17, 2015.

On August 10, 2015, PREPA filed a motion titled *Notificación de Estatus de Cumplimiento con Orden de 3 de Agosto de 2015* stating that they would be able to submit on time the corrections for Volumes I, III and IV. However, PREPA stated that, in order to provide the required data and analysis in relation to Volume V of the IRP (Evaluation of DG Impacts on the Distribution System), PREPA has to perform complementary simulations that would require additional time beyond August 17, 2015. Specifically, PREPA requested an extension of time of sixty (60) days to submit the corrections to Volume V.

Having examined PREPA's motion, its request for a time extension is partially granted. PREPA must file a Second IRP Update, which shall include all the data and analysis required in the August 3 Order in relation to "Volume V: Evaluation of DG Impacts on the Distribution System", on or before September 30, 2015. PREPA must correct the deficiencies related to Volumes I, III and IV in its August 17, 2015 IRP update as ordered by the Commission on August 3, 2015.



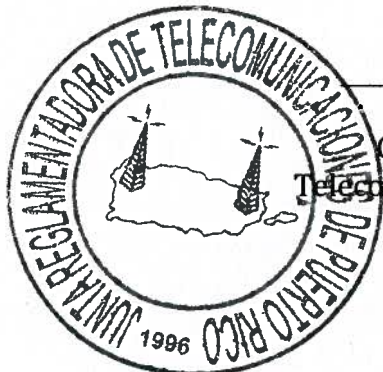
