**PREPA'S VERIFIED MOTION FOR LIMITED EXTENSION OF TIME**

TO THE HONORABLE PUERTO RICO ENERGY COMMISSION:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") and requests that the Puerto Rico Energy Commission's (the "Commission"), with respect to its June 15, 2016, Order asking for information and clarification as well as for certain associated documents ("June 15<sup>th</sup> Order"), briefly extend the response deadline of June 17, 2016, at 4:30 p.m. This Motion is supported by a Verification. In support of its Motion, PREPA states as follows:

1. PREPA, along with its applicable subject matter expert advisors, has been diligently working to prepare a complete and correct response to the June 15<sup>th</sup> Order. Such a response requires not only information and clarification in a general sense, but also data and certain documents. In addition, when finalized, the response needs a supporting verification.

2. Despite the exercise of due diligence, PREPA is concerned that it may not be able to finalize the response, including its attachments, by 4:30 p.m. today, and that, once finalized, simply for practical reasons, it may take some additional time to obtain the verification.

3. PREPA currently anticipates that it likely will be able to submit the response by Monday, June 20, 2016, although it will exercise its best reasonable efforts to comply earlier than that, if possible.




4. PREPA accordingly asks that the Commission extend the deadline to 1:00 p.m. on Monday, June 20, 2016, with the understanding that PREPA will use its best reasonable efforts to submit the response earlier than that, if possible.

WHEREFORE, the Puerto Rico Electric Power Authority respectfully requests that the Commission grant this Motion, and allow PREPA until 1:00 p.m. on Monday, June 20, 2016, to respond to the June 15<sup>th</sup> Order, with the understanding that PREPA will use its best reasonable efforts to comply earlier than that, if possible.


