SUBJECT: PREPA's Motion to Reconsider the Final Resolution and Order of the First Integrated Resource Plan for the Puerto Rico Electric Power Authority.

RESOLUTION

On September 26, 2016, the Puerto Rico Energy Commission ("Commission") issued its Final Resolution and Order on the First Integrated Resource Plan of the Puerto Rico Electric Power Authority ("Final Resolution"). On October 13, 2016, within twenty (20) days from the filing of the Final Resolution's notification¹, the Puerto Rico Electric Power Authority ("PREPA") filed before the Commission a motion for reconsideration titled *PREPA's Verified Motion for Reconsideration of Provisions of the Final Resolution and Order* ("Motion to Reconsider"), in which PREPA requests the Commission to reconsider its Final Resolution.

Through this Resolution, the Commission **NOTIFIES** that it will consider PREPA's timely filed Motion to Reconsider and will issue a final determination on its merits pursuant to Section 3.15 of the Uniform Administrative Procedure Act ("UAPA")².

For the benefit of all parties and in order to have a complete administrative record, the Commission **INVITES** all intervenors in this proceeding to express their opinion with respect to PREPA's Motion to Reconsider. Intervenors' opinions must be limited to the arguments presented by PREPA in its Motion to Reconsider. Said opinions shall be filed in writing before the Commission's Clerk no later than **November 2, 2016**. Due to the terms set forth in Section 3.15 of the UAPA for the Commission to issue its final determination on its merits, the term to file intervenor's opinions with regards to the Motion to Reconsider will not be extended.


For the benefit of all the parties involved, the Commission issues this Resolution in English and Spanish. Should any discrepancy between each version arise, the Spanish version shall prevail.

¹ Both Section 11.01 of Regulation No. 8543, Regulation of Adjudicative Proceedings, Notice of Noncompliance, Rate Reviews and Investigations, as well as Section 3.15 of Act 170 of August 12, 1988, as amended, also known as the Uniform Administrative Procedure Act, establish that any party adversely affected by said Final Resolution may file a motion to reconsider before the Commission within said twenty-days (20) term, from the filing of the Final Resolution's notification.




