RESOLUTION

On November 21st, 2016, the Independent Consumer Protection Office ("ICPO") filed with the Puerto Rico Energy Commission ("Commission") a document titled "*Escrito en Solicitud de Orden*" ["Brief Requesting an Order"] ("Brief").¹ With said Brief, the ICPO submits certain recommendations and comments, which it believes should be considered by the Commission when making its decisions on the content of the information to be included in the "transparent bill".

With this Resolution, the Commission **ACCEPTS** the ICPO's Brief as part of its comments and arguments in the present proceeding. These shall be examined during the process of analysis, along with the rest of the information gathered. Accordingly, the Commission shall address the issues raised by the ICPO, as well as any other, in its final ruling with respect to the present proceeding.

For the benefit of all parties involved, the Commission publishes the present Resolution in both the Spanish and the English languages. Should any conflict arise between the two versions, the Spanish version shall prevail.

Be it notified and published.

¹ While the brief presented by the ICPO is titled "*Escrito en Solicitud de Orden*" ["Brief Requesting an Order"], a reading of said document reveals that it is a brief in "Compliance with an Order". Once again, we call upon the ICPO to adjust its filings to the directives, rules, and norms established by the Commission for participation in the matters before its consideration. In this way, their participation will be more effective and unnecessary delays will be avoided in future proceedings before the Commission.
