SUBJECT: Ruling on PREPA's Motion for
Extension of Time.


RESOLUTION

On February 27, 2017, Mr. Marc Bejarano ("Petitioner") filed a "petition for bill review" with the Puerto Rico Energy Commission ("Commission"), against the Puerto Rico Electric Power Authority ("PREPA" or "Respondent"). As established in Section 3.03 of Regulation 8543,¹ the respondent shall "respond to the pleadings within a period of twenty (20) days" from the date the petition was filed and noticed.

On March 16, 2017, PREPA filed a *Motion for Extension of Time* in the instant case requesting an extension of twenty (20) days from the due date established on Regulation 8543, to file an opposition to the Petitioner's claim. PREPA argues that it "needs to thoroughly examine Petitioner's account history before responsibly stating its position on Petitioner's claim."²

In light of the aforementioned, the Commission **GRANTS** the extension of time requested by PREPA. PREPA shall present its response to the pleadings set forth by the Petitioner **on or before April 10, 2017**.
