SUBJECT: Motions to withdraw legal
representation from CEMEX and PRASA

RESOLUTION AND ORDER

On June 29, 2017, CEMEX de Puerto Rico, Inc. ("CEMEX") filed before the Puerto Rico Energy Commission ("Commission") a motion titled *Moción Urgente Solicitando Relevó de Representación Legal*. In its motion, CEMEX informs that its counsel, Edwin A. Irizarry Lugo, was appointed as member of the Puerto Rico Electric Power Authority's Governing Board and will not be able to represent the intervening party in the instant proceeding. Furthermore, CEMEX requests that the Commission notifies any future correspondence or documents in the instant proceeding to Nydin M. Watlington, Esq.

On June 30, 2017, the Puerto Rico Aqueduct and Sewer Authority ("PRASA") filed a motion titled Motion to Withdraw as Attorney of Record. In its motion, attorney Pedro Santiago Rivera states that PRASA requested him to withdraw as its legal representation in the instant case. Attorney Santiago further states that attorney Maribel Cruz de León will continue to represent PRASA in the instant proceeding, as she has done in the past.

Through this Resolution and Order the Commission **GRANTS** the requests made by CEMEX and PRASA regarding their respective legal representation. The Commission **ORDERS** the Commission's Clerk and the parties to prospectively notify the legal representation from CEMEX and PRASA at the following addresses:
