
**SUBJECT:** Instituto de Competitividad y

**ORDER**


On October 5, 2018, the Puerto Rico Economic Competitiveness and Sustainability Institute ("ICSE", by its Spanish acronym) filed before the Puerto Rico Energy Bureau ("Energy Bureau") a document titled *Motion Commenting PREPA's Informative Motion Regarding IRP Timeline*. In summary, ICSE alleges that by postponing the compliance with the Energy Bureau orders regarding the IRP timeline, the Puerto Rico Electric Power Authority ("PREPA") might decide and/or enter into contracts and take other actions which might be irreversible and severely limit the effectiveness of the IRP and the Energy Bureau's ability to perform its responsibilities.


In order to be in position to rule on ICSE's motion, PREPA is **ORDERED** to, on or before **twenty (20) days** from the notification date of this Order, submit its comments regarding ICSE's argument with respect to contracts and actions that might limit the effectiveness of the IRP.
