Motion Regarding its Accompanying
Integrated Resource Plan Filing.

RESOLUTION AND ORDER

On February 13, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Puerto Rico Energy Bureau ("Energy Bureau") a motion titled *PREPA's Petition and Informative Motion Regarding its Accompanying Integrated Resource Plan Filing* ("IRP Filing"). As part of its IRP Filing, PREPA included the following documents:

1. PREPA Exhibit 1.0, which includes the IRP Main Report and five Appendices;
2. PREPA Exhibit 2.0, which comprises the work papers of the IRP;
3. PREPA Exhibits 3.0 through 7.0, which include Direct Testimony with attachments and notarizations.¹

Additionally, PREPA filed a motion titled *PREPA's Motion for Limited Waivers of Filing Requirements under Regulation No. 9021* ("Motion for Limited Waivers"), and *PREPA's Motion for Confidential Treatment of Portions of its Integrated Resource Plan Filing* ("Motion for Confidential Treatment"). PREPA's Motion for Limited Waivers and Motion for Confidential Treatment will be addressed by the Energy Bureau through separate determinations on the instant case.

I. PREPA's IRP Filing.

Section 3.02(A) of Regulation 9021² establishes that, upon PREPA's filing of a proposed IRP, the Energy Bureau will have thirty (30) days to review such filing in order to determine whether it complies with the applicable regulatory requirements. Given the fact that, on February 13, 2019, PREPA submitted its IRP Filing before the Energy Bureau, the thirty (30) day term established on Section 3.02(A) of Regulation 9021 is applicable. Therefore, the Energy Bureau is in the process of evaluating PREPA's IRP Filing and will issue its determination within such term.

Given that PREPA submitted its proposed IRP as part of the IRP Filing, the documents contained therein are part of the docket in the instant case. For the benefit of interested parties and the general public, the Energy Bureau will publish all non-confidential and redacted documents included in PREPA's IRP Filing. However, it is important to state that this action **shall not be construed** as a determination of completeness pursuant Section 3.02(A) of Regulation 9021. As such, the Energy Bureau **will not consider at this time** petitions to intervene, discovery requests or any other dispositive or procedural matters.

If the Energy Bureau determines that PREPA filed a complete IRP, it will issue a resolution establishing the procedural calendar of the instant case. Such procedural calendar will include the period for interested parties to file their petitions for intervention, the period to conduct discovery, the technical conferences dates, and all other procedural matters.

The Energy Bureau **DETERMINES** that PREPA's IRP Filing is part of the docket in the instant case, and as such, all non-confidential and redacted documents will be made available to the general public and hereby **ORDERS** the Energy Bureau's Clerk to publish all non-confidential and redacted documents related to PREPA's IRP Filing on the Energy Bureau's website.
