SUBJECT: PREPA's Refiling of Certain Documents and Request for Additional Information.

RESOLUTION AND ORDER

On March 28, 2019, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") held a Technical Conference (via telephone) with the Puerto Rico Electric Power Authority ("PREPA"). The purpose of the Technical Conference was to discuss certain information contained in PREPA's proposed Fuel, Purchased Power and Subsidies factors to be used in the implementation of the Permanent Rate on May 1, 2019. During the Technical Conference, the Energy Bureau instructed PREPA to provide certain information and to make several corrections or modifications to the documents related to the calculation of the aforementioned factors. This Resolution and Order contains the specific information and documents PREPA must provide to comply with the requests made during the technical conference.

In addition to the factors to be implemented on May 1, 2019, the Energy Bureau is analyzing the proposed factors to reconcile the provisional rate and the permanent rate, as well as the yearly and quarterly Fuel, Purchased Power and Subsidies factors to be applied on July 1, 2019. Based on our initial review of the documents provided in PREPA's compliance filings of February 21, 2019 and March 1, 2019, in the instant case, we determined that additional information is required. Appendix A to this Resolution and Order details the required information and documents associated with these factors.

Moreover, on March 29, 2019, PREPA filed a document titled "PREPA's Motion for Extension of Time for Updated Factor Calculations in Order to Allow Application of arch 28th Technical Conference Discussion" ("Motion"). In its Motion, PREPA request to extend the April 1, 2019, deadline for submission of the updated calculations of the fuel, purchased power and subsidies factors to be implemented on May 1, 2019. PREPA argued that the topics discussed during the March 28 Technical Conference will affect such calculations. After reviewing PREPA's arguments, the Energy Bureau **GRANTS** PREPA's request for extension of the April 1 deadline. As such, PREPA must submit the updated calculations of the fuel, purchased power and subsidies factors to be implemented on May 1, 2019 on or before April 3, 2019.

Therefore, the Energy Bureau **ORDERS** PREPA to (i) on or before 12:00 p.m. on April 3, 2019, file with the Energy Bureau the documents and information detailed in Sections (I) and (II) of Appendix A to this Resolution and Order, including updated calculations of the 1 duel, purchased power and subsidies factors to be implemented on May 1, 2019; and (ii) attend a Technical Conference (via telephone) at 10:00 a.m. on Friday, April 5, 2019 in order for PREPA to provide a thorough walkthrough of the documents listed in Section (III) of Appendix A to this Resolution and Order.

All interested persons are welcomed to listen to the conference, however, the Energy Bureau will not allow questions from such participants.

(1) Provide a corrected version of the file identified as "Top CILT calculations 20190320.xlx", using the methodology to calculate the municipal CILT allotment as established in Section 2.03 of Regulation 8818.

- (2) On the "TOP Calculations" tab of the file identified as "Top CILT calculations 20190320.xlx", please identify and provide the source documents for column F, "2014 kWh Profit", and column G, "New SA's between 07/2014 and 06/2016".
- (3) Provide a list, by municipality, of the installations associated with the consumption listed on column G, "New SA's between 07/2014 and 06/2016" of the "TOP Calculations" tab of the file identified as "Top CILT calculations 20190320.xlx". Also, for each installation, provide evidence that such installation complies with the requirements of Section 2.04 of Regulation 8818.
- (4) Refer to the files identified as "Calculo costo del CELI 2019 (Modificado).xlx" and "Calculo costo del CELI 2019.xlx". Provide the source data and methodology to calculate the distribution factors contained in the "Proporciones" tab.
- (5) Refer to the file identified as "ESTIMADO LUMINARIAS AFECTADAS POR MUNICIPIO 18 marzo 2019.xlx". Provide clarification of the term "LUMINARIAS AFECTADAS", contained on all tabs. Also, provide clarification of the term "LUMINARIAS REPARADAS (INFORMES)".
- (6) As discussed in the March 28, 2019 Technical Conference, according to PREPA's data, only 85% of the public lighting is operating at this time. PREPA must use such percentage in the calculation of the estimated cost of municipal public lighting to be included in the subsidies' rider. PREPA must modify its work papers and proposed factor calculation sheets, as needed, to reflect this change. PREPA may opt to adjust the estimated cost of public lighting on a per-municipality basis, if such data is available. PREPA must provide a narrative of the changes made to its work papers and Excel files to reflect this directive.
- (7) Refer to the file identified as "Subsidios 2019 (Modificado).xlx". On tab "RFR" cells L15 to L18 and L25 to L27 must contain the same formulas as cells L7 to L9. PREPA must correct these discrepancies and refile the document.
- (8) Refer to the files identified as "Ingresos mensuales 2019 (Modificado).xlx" and "Ingresos mensuales 2019.xlx". Provide the source data and methodology to calculate the values of cells D2 to D6 and D9 to E14 of the tabs "apr", "may" and "jun".
- (9) Provide updated versions of the following files to reflect the rate implementation date of May 1, 2019 (*i.e.*, eliminate the April data and its effects on the calculation
