PREPA'S COMPLIANCE FILING

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") and respectfully submits, to the honorable Puerto Rico Energy Bureau (the "Energy Bureau"), PREPA's Compliance Filing in accordance with the Energy Bureau's Resolution and Order of June 11, 2019.

1. The June 11th order directs PREPA to submit by 12:00 p.m. on June 14, 2019, the required electronic work papers relating to PREPA's June 7, 2019, Integrated Resource Plan ("IRP") filing.

2. Meanwhile, PREPA's June 11, 2019, Informative Motion and Motion to Coordinate Overlapping Schedules, filed before receipt of the June 11th order, proposed that PREPA submit the electronic work papers on a rolling basis to be completed by June 14th.

3. In accordance with the June 11th order and the June 11th Motion, PREPA is providing today, June 12, 2019, certain of the electronic work papers. Consistent with past practice, and with the Energy Bureau's requirement that applicable work papers be produced in native (functional) format (reg. No. 9021, § 2.02(F)(1)), the work papers are being submitted on a USB drive.


