**PREPA'S MOTION FOR TWO MORE DAYS
TO SUBMIT REVISED CONFIDENTIALITY REQUESTS**

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") and respectfully submits, to the honorable Puerto Rico Energy Bureau (the "Energy Bureau"), PREPA's Motion for Two More Days to Submit Revised Confidentiality Requests.

1. On June 7, 2019, PREPA filed its Motion for Confidential Treatment of Portions of Its Integrated Resource Plan Filing.

2. On June 18, 2019, at 4:32 pm, the Energy Bureau issued a Resolution and Order directing PREPA to update and clarify the June 7th motion with respect to the electronic work papers submitted by PREPA from June 12 to June 14, 2019, and to update the file names of those documents as needed. The order directs PREPA to do so by today, June 19, 2019, at 12:00 p.m.

3. PREPA agrees with the June 18th order's directives, but respectfully requests that the Energy Bureau change the deadline to June 21, 2019, at 12:00 p.m. PREPA is working actively on other compliance work due this week in this docket and the 2015 rate implementation docket and on possible motions to be filed in these two

dockets. Complying with the June 18th order within a matter of hours is very difficult and complicates the workflow for the other compliance matters.

WHEREFORE, the Puerto Rico Electric Power Authority respectfully requests that the Honorable Puerto Rico Energy Bureau grant the foregoing Motion; change the referenced due date to June 21, 2019, at 12:00 pm and, enter such other relief as is warranted.
