PREPA'S COMPLIANCE FILING

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority ("PREPA") and respectfully submits to the honorable Puerto Rico Energy Bureau (the "Energy Bureau") PREPA's Compliance Filing pursuant to the Energy Bureau's Resolution and Order of June 25, 2019.

1. PREPA is submitting with this Filing in electronic form on a "USB" drive (a) a file that is an index of the documents being filed and (b) the files.

2. Please note that the index lists three documents as "Pending". Two of those "Pending" documents are older documents that compare 2015 ad 2018 data and that likely were prepared by a former Siemens IRP team member who left Siemens at the end of 2018. Siemens is diligently reviewing its records to locate those documents. The other "Pending" document is a document that Siemens is in the process of verifying.

3. Please also note that the index lists two items as "Not available". One document is a source document that is subject to copyright of IHS Markit and that is available to subscribers only. The index lists the source. The other item is a model belonging to a third party, AWS Truepower, which is not available. AWS Truepower used the model to create the referenced meteorological information provided.

WHEREFORE, the Puerto Rico Electric Power Authority respectfully requests that the Honorable Puerto Rico Energy Bureau accept this Filing, subject to Siemens using its best efforts to provide the three "Pending" documents as soon as reasonably practical, and enter any other relief as is warranted.
