RESOLUTION AND ORDER

On June 19, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed two (2) documents before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau"), titled: (i) *PREPA's Motion for Leave to File Attachments Inadvertently Omitted from June 14th Filing and to Remove Copies of Personal Information* ("Motion for Leave") and (ii) *PREPA's Motion for Two More Days to Submit Revised Confidentiality Requests* ("Motion for Extension"). Both Motions will be addressed in this Resolution and Order.

I. PREPA's Motion for Leave to File Attachments Inadvertently Omitted from June 14th Filing and to Remove Copies of Personal Information

Through its Motion for Leave, PREPA requested permission to file five (5) documents related to the *curriculum vitae* ("CV") of several of its expert witnesses, as well as a copy of PREPA's Governing Board Resolution 4676. PREPA stated that due to an inadvertent error the referenced documents were not included in the June 14, 2019 compliance filing. PREPA argued that although the CVs are part of the witnesses' testimony, they are not substantive evidence on the instant case. Furthermore, PREPA stated that the Governing Board's Resolution is a public document. Lastly, PREPA informed the Energy Bureau that copies of the driver's licenses of several witnesses were attached to the testimony attestations. PREPA argued that since such documents contain personal information that is not pertinent to the instant case, they should not be made part of the docket.

Upon review of PREPA's Motion for Leave, the Energy Bureau **GRANTS** PREPA's requests. PREPA Exhibits 3.01, 3.02, 4.01, 5.01 and 6.01, as filed jointly with the Motion for Leave are included as part of the docket in the instant case. Furthermore, the Energy Bureau **ORDERS** the Clerk of the Energy Bureau to remove the driver's licenses of PREPA's witnesses from both the hard copies of PREPA's June 14, 2019 filing and the electronic copies available at the Energy Bureau's website.

II. PREPA's Motion for Two More Days to Submit Revised Confidentiality Requests

On June 18, 2019, the Energy Bureau issued a Resolution and Order ("June 18 Resolution and Order") through which it requested PREPA to submit, on or before 12:00 p.m. on June 19, 2019, a detailed, specific and coherent list of the documents for which

confidential treatment was sought and correct the names of the submitted electronic files. Through its Motion for Extension, PREPA seeks two (2) additional days, until June 21, 2019, at 12:00 p.m., in order to provide the information required by the Energy Bureau in the June 18 Resolution and Order. PREPA states that the additional time is required given that it is working actively in other compliance matters before the Energy Bureau.

Upon review of PREPA's arguments, the Energy Bureau **GRANTS** PREPA's request. The Energy Bureau **ORDERS** PREPA to file the information required in the June 18 Resolution and Order **on or before June 21, 2019, at 12:00 p.m.**


