RESOLUTION

On July 5, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed a document titled *PREPA'S Interim Compliance Filing RE July 2, 2019, Order, and Motion for Reconsideration on General or Interim Basis* ("July 5 Motion") before the Puerto Rico Energy Bureau ("Energy Bureau").

Section 2.02 (F) of Regulation 8543¹ states:

"Every pleading, motion or document presented before the Energy [Bureau] must comply with the following requirements:

...

- F) The document **shall be signed by the appearing party's lawyer**, or by the party themselves, if not legally represented. The signature of the party or the party's attorney shall constitute a certification that the undersigned has read the document and, to the best of his knowledge, understanding and belief, formed after reasonable examination, the information submitted is true and accurate. The name, last names, physical address, mailing address, telephone number and email address of the undersigned shall be indicated on top or beneath the signature. When a lawyer appears in representation of a party, all writings must also include the attorney's registration number...." (Emphasis added).

The July 5, 2019 Motion is not signed by the appearing party's lawyer. Hence, the Energy Bureau cannot consider the motion until it is properly filed. The Energy Bureau **ORDERS** PREPA to, within five (5) days of the notification of this Resolution and Order, file the foregoing motion in accordance with the provisions of Regulation 8543.
