## **RESOLUTION**

On July 3, 2019, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order in the instant case regarding the Integrated Resource Plan ("IRP") Filing submitted by the Puerto Rico Electric Power Authority ("PREPA") on June 7, 2019 ("July 3 Resolution and Order"). Through the July 3 Resolution and Order, the Energy Bureau determined that PREPA complied with the requirements established on Regulation 9021. The Energy Bureau also decided it was necessary to commence Phase 2 of the IRP approval process, as established on Regulation 9021, and issued the Procedural Calendar for this case.

As of the issuance of this Resolution and Order, the Energy Bureau has granted the intervention and participation as *Amicus Curiae* to over fifteen (15) entities ("Entities"). To ensure procedural efficiency, the Energy Bureau **DETERMINES** that (i) the Energy Bureau will notify all interlocutory Resolutions and Orders issued in the instant case, via electronic mail to each party using the electronic mail address on record; (ii) all legal memoranda, motions, briefs and any documentation related to the same filed by the Entities in the instant case will be notified by the filing entity to the other Entities via electronic mail using the electronic mail address on record. It is the Entities' responsibility to ensure their electronic mail address on record is correct. The Energy Bureau will notify the Final Resolution and Order in the instant case, via electronic mail and regular mail and in accordance with the provisions of Act 38-2017.<sup>3</sup>

The Energy Bureau **REMINDS** all Entities of the importance of complying with the provisions of Regulation 8543<sup>4</sup> and **WARNS** them that noncompliance with the provisions of this Resolution and Order may result in the imposition of administrative fines up to
