**RESOLUTION AND ORDER**

On August 8, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *PREPA's Motion for Reconsideration Regarding Initial Technical Hearing Second Day Schedule* ("Motion"). Through its Motion, PREPA requests reconsideration on the August 6, 2019 Resolution and Order in the instant case regarding the schedule for the second day of the Initial Technical Hearing.

As part of its Motion, PREPA presents additional details as to the cause why Siemens' personnel will not be available during the second day of the Initial Technical Hearing, scheduled for August 14, 2019. PREPA had an opportunity to present the aforementioned information as part of its August 1, 2019 *Motion regarding Initial Technical Hearing and Procedural Calendar* but did not.

Upon review of PREPA's arguments, the Energy Bureau **DETERMINES** the following:

1. The first part of the Initial Technical Hearing will be held **on August 13, 2019, commencing at 7:30 a.m.** The issues to be discussed during this date, as stated in the July 26, 2019 Resolution,<sup>1</sup> **remain unaltered.**
2. The Energy Bureau will hold the second part of the Initial Technical Hearing on **September 4, 2019.** At the Bureau's discretion, the Initial Technical Hearing may be **extended to September 5, 2019, if necessary.** The Energy Bureau will discuss the issues established for the second part of the Initial Technical Hearing, as stated in the July 26, 2019 Resolution.


There will be **no additional changes** to the schedule of the Initial Technical Hearing. PREPA and Siemens shall make any arrangements necessary to make available the personnel that can answer questions during the Initial Technical Hearing, as set forth above. If a major

conflict arises which makes it **impossible** for any Siemens personnel to attend, other than a conflict on the agenda, must be notified **on or before August 12, 2019**.

The Energy Bureau **WARNS** PREPA that noncompliance with the provisions of this Resolution and Order will be construed as a violation of the Energy Bureau's orders and may result in the imposition of administrative fines up to twenty-five thousand dollars (\$25,000) per day, per violation, as well as any other administrative sanctions the Energy Bureau deems necessary, in accordance with the applicable statutes and regulations.


