**RESOLUTION AND ORDER**

On August 14, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Notice of Appearance on Behalf of the Puerto Rico Electric Power Authority* ("Motion"). Through its Motion, PREPA informed the two (2) attorneys that will appear as PREPA's legal representatives in the instant case.

Upon review of PREPA's Motion, the Energy Bureau **TAKES NOTICE** of the information submitted.
