
SUBJECT: Motion in Compliance with Order

RESOLUTION AND ORDER

On July 8, 2019, SunEdison Puerto Rico, LLC, (“SunEdison”) filed a motion titled *Motion in Compliance with Order Dated June 21, 2019, and For Reconsideration* before the Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”). As part of its filing, SunEdison submitted the payment of the five hundred dollars (\$500.00) fine imposed by the Energy Bureau in compliance with the June 21, 2019 order. SunEdison requested the Energy Bureau to reconsider its order regarding the submittal of its Operational Report before the Puerto Rico Energy Public Policy Program (“EPPP”), until they execute a non-disclosure agreement with the EPPP. SunEdison requests to be granted an additional term of twenty (20) days to execute a non-disclosure agreement with the EPPP, submit its Operational Report to said Program and to provide the Energy Bureau evidence thereof.

Upon examining SunEdison arguments, the Energy Bureau **ACKNOWLEDGES** SunEdison Motion and **GRANTS** the time extension requested. The Energy Bureau **ORDERS** SunEdison to file said document **by August 6, 2019**. The Energy Bureau **WARNS** SunEdison that noncompliance with the Energy Bureau orders and Regulations is sufficient cause for imposing additional fines and other administrative penalties, under Act 57-2014 and all applicable regulations.


