

RESOLUTION AND ORDER

On September 6, 2019, Wartsila North America, Inc. (“Wartsila”) filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board (“Energy Bureau”) a document titled *Notice of appearance on behalf of Wartsila North America, Inc.* (“Motion”). Through its Motion, Wartsila notified that attorneys Shemin Varinnia Proctor and Gia Vassanelli Cribbs appear as co-counsel in the instant case, in addition to attorney Eugene Scott. Wartsila states that both Ms. Proctor and Ms. Cribbs were granted admission *pro hac vice* by the Supreme Court of Puerto Rico to appear as co-counsel on behalf of Wartsila in the instant case only.¹

Upon review of Wartsila’s Motion, the Energy Bureau **TAKES NOTICE** of Wartsila’s legal representation. However, to avoid undue delays in this proceeding, the Energy Bureau **ORDERS** Wartsila to, **within five (5) days** of the notification of this Resolution and Order, provide the names of the two (2) legal representatives that will actively participate in the instant case procedures (*i.e.*, technical conferences and evidentiary hearings) as lead counsel on behalf of Wartsila.


