MOTION IN COMPLIANCE WITH RESOLUTION AND ORDER

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW Wärtsilä North America, Inc. (“Wärtsilä”), through the undersigned attorneys, and respectfully states and prays as follows:

1. On August 2, 2019, Wärtsilä, through the undersigned counsel Eugene Scott Amy, filed a Petition to Intervene, which was granted by this Honorable Bureau on August 5, 2019.
2. On September 6, 2019, Wärtsilä filed a Notice of Appearance for counsel Shemin V. Proctor and Gia V. Cribbs.
3. On September 23, 2019, the Energy Bureau notified a Resolution and Order determining that it “takes notice of Wärtsilä’s legal representation. WHEREFORE, it is respectfully requested that this Honorable Bureau take notice of the aforementioned and deem complied with the Resolution and Order notified on September 23, 2019.
