RESOLUTION

On September 23, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *PREPA's Request for Approval of Contract Release Number 10 and Contract Release Number 11* ("Motion"). Through its Motion, PREPA provided the draft Siemens Contract Releases 10 and 11 for the Energy Bureau's approval, as ordered on the July 16, 2019 Resolution and Order in the instant case.¹

In the Motion, PREPA stated that each draft Contract Release includes a detailed description of the consulting services to be provided by Siemens and that each draft Contract Release includes a specific breakdown of the total compensation per task.

Upon review of the Motion, the Energy Bureau **TAKES NOTICE** of the information submitted, and **GRANTS** PREPA leave to execute Contract Releases 10 and 11.
