RESOLUTION AND ORDER

On September 21, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Omnibus Motion for Extension of Time to Submit Responses to Several Requirements for Information* ("Motion"). Through its Motion, PREPA states that since August 26, 2019 it has received six (6) requests for information submitted by intervenors,¹ including a second Requirement of Information ("ROI") from the Not for Profit Intervenors issued on September 15, 2019.

The Energy Bureau has no record of a second ROI from the Not for Profit Intervenors being issued. Regarding the instructions for the discovery process in the instant case, the Energy Bureau has been clear that every ROI and the corresponding answers shall be notified by email to the address on record of every intervenor **and to the Energy Bureau.**²

The Not for Profit Intervenors have deliberately ignored the Energy Bureau's orders regarding the instructions in the discovery process. As an example, as part of the August 30, 2019 Resolution and Order³ in the instant case, the Energy Bureau ordered the Not for Profit Intervenors to send a copy, via email, to the Energy Bureau of its first ROI, since the Energy Bureau had not been notified of said ROI.

In light of the above, the Energy Bureau **ORDERS** the Not for Profit Intervenors to, **within two (2) days of the notification of this Resolution and Order**, submit a copy, via email, of the second ROI served on September 15, 2019.




