RESOLUTION

On September 27, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *PREPA's Request for Approval of Contract Release Number 12* ("Motion"). Through its Motion, PREPA provided the draft Siemens Contract Release 12 ("CR-12"), as ordered on the July 16, 2019 Resolution and Order in the instant case.¹

In the Motion, PREPA stated that the draft CR-12 includes a detailed description of the consulting services to be provided by Siemens and a specific breakdown of the total compensation per task.²

Upon review of the Motion, the Energy Bureau **TAKES NOTICE** of the information submitted, and **GRANTS** PREPA leave to execute CR-12.
