RESOLUTION

On November 6, 2019, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Request for Approval of Contract Release Number 13* ("Motion"). Through its Motion, PREPA provided the draft Siemens Contract Release 13 ("CR-13"), as ordered on the July 16, 2019 Resolution and Order in the instant case.¹

In the Motion, PREPA stated that the draft CR-13 includes a detailed description of the consulting services to be provided by Siemens and a specific breakdown of the total compensation per task.² According to PREPA, the purpose of CR-13 is to provide services in response to two requests for additional sensitivities and information from AES-Puerto Rico and the Energy Bureau.³

Upon review of the Motion, the Energy Bureau **TAKES NOTICE** of the information submitted, and **GRANTS** PREPA leave to execute CR-13.


