ORDER


On November 26, 2019, the Not for Profit Entities filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion Requesting Order to PREPA Concerning Alleged Grid Modernization Plan* ("Motion"). The Not for Profit Entities alleges that, on October 24, 2019, the Puerto Rico Electric Power Authority ("PREPA") announced a plan called *The Grid Modernization Plan* ("Grid Mod Plan").¹ The Non for Profit Entities stated that, although the Grid Mod Plan impacts the Integrated Resource Plan ("IRP"), PREPA has not included it in the IRP process pending before the Energy Bureau.² According to the Not for Profit Entities, Act 57-2014³ requires the actions presented in the Grid Mod Plan to be included and considered in the IRP evaluation process.⁴ For this reason, the Not for Profit Entities requests the Energy Bureau to order PREPA to submit the Grid Mod Plan proposal as an amendment to the IRP.⁵

The Energy Bureau **ORDERS** PREPA to, **within ten (10) days** from the notification date of this Order, show cause as to why the Energy Bureau should not order PREPA to submit the Grid Mod Plan proposal as an amendment to the IRP.
