**MOTION REQUESTING ACTION BY THE PUERTO RICO ENERGY BUREAU  
CONCERNING PREPA's NON COMPLIANCE WITH PREB ORDERS**

TO THE BUREAU:

NOW COMES, INSTITUTO DE COMPETITIVIDAD Y SOSTENIBILIDAD ECONOMICA DE PUERTO RICO (ICSE) represented by Appearing Counsel and respectfully alleges and prays:

1. On October 30, 2018 the PREB issued an Order, on the Review of The Puerto Rico Electric Power Authority Integrated Resource Plan, case number CEPR-AP-2018-0001 stating:

"In order to be in position to rule on ICSE's motion, PREPA is ORDERED to, on or before twenty (20) days from the notification date of this Order, submit its comments regarding ICSE's argument with respect to contracts and actions that might limit the effectiveness of the IRP."

2. Also on October 30<sup>th</sup> 2018 on the proceeding for the Review of The Puerto Rico Electric Power Authority FY19 Rates, case number CEPR-AP-2018-0002 the Bureau stated:

"In order to be in a position to rule on ICSE's motion, PREPA is ORDERED to, on or before twenty (20) days from the notification date of this order, submit its comments regarding ICSE's arguments."


3. As today November 29, 2018, PREPA has not complied with the two orders.

WHEREFORE: the Puerto Rico Institute for Competitiveness and Sustainable Economic respectfully requests the PREB to order PREPA to immediately comply with the two orders referred in this motion, and deny PREPA's requests until it complies with the orders.
