RESOLUTION


On January 23, 2020, Environmental Defense Fund ("EDF") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion for Evidentiary Hearing Appearance Scheduling* ("Motion"). Through its Motion, EDF states that its expert witness in the instant case, Dr. Elizabeth A. Stanton, has prior professional commitments on the last day of the Evidentiary Hearing to be held from February 3, 2020 until February 7, 2020. EDF states that Dr. Stanton can only be available for appearance and cross-examination on February 4-6, 2020. Therefore, EDF requests the Energy Bureau to waive Dr. Stanton from appearing on the last day of the scheduled Evidentiary Hearing.

The Energy Bureau established the Evidentiary Hearing format and schedule as part of the January 17, 2020 Resolution ("January 17 Resolution") in the instant case.¹ Based on said schedule, Panel I and Panel J will be held on February 7, 2020 and require the appearance of Dr. Stanton. However, based on the January 17 Resolution, Panel I begins on February 6, 2020.


Upon review of EDF's Motion, the Energy Bureau **DETERMINES** all questions or cross-examination addressed to Dr. Stanton during Panel I shall be made at the beginning of the panel, which is currently scheduled to start at 4:00 p.m on February 6, 2020. Additionally, the Energy Bureau **WAIVES** Dr. Stanton from her appearance on Panel J of the Evidentiary Hearing.


