RESOLUTION

In the interest of ensuring ample public participation with regards to the evaluation of the Integrated Resource Plan ("IRP") filed by the Puerto Rico Electric Power Authority ("PREPA"), the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") will hold five (5) Public Hearings in different places around the Island. During the Public Hearings, the general public will have the opportunity to present their comments regarding the IRP filed by PREPA. Since the Public Hearings are designed to obtain comments from the general public, Intervenors, PREPA or its employees, associates, witnesses or legal representation, and any other party to this proceeding, will not be allowed to participate in the public hearings.
