Counsel for AES Puerto Rico, L.P.

RESOLUTION AND ORDER

On January 29, 2020, AES Puerto Rico, L.P. ("AES-PR") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion for Substitution of Counsel for AES Puerto Rico, L.P.* ("Motion"). Through its Motion, AES-PR notified the withdrawal of Attorney Manuel A. Pietrantonio as counsel of record for AES-PR. Furthermore, AES-PR notified that Attorneys Samuel B. Boxerman and Benjamin M. Mundel will substitute Attorney Pietrantonio as AES-PR legal counsel, along with Attorney Pagán. AES-PR states that Mr. Boxerman and Mr. Mundel were granted admission *pro hac vice* by the Supreme Court of Puerto Rico to appear as co-counsel on behalf of AES-PR in the instant case only.¹

Upon review of AES-PR's Motion, the Energy Bureau **TAKES NOTICE** of AES-PR's legal representation, and **GRANTS** Mr. Pietrantonio's request to withdrawal as counsel of record for AES-PR in the instant case. The Energy Bureau **WARNS** AES-PR's legal counsel that it must adhere to all procedural processes established by the Energy Bureau, including, but not limited to, the established instructions for the witness examination during the Evidentiary Hearing.² Finally, the Energy Bureau **ORDERS** all parties in the instant case to prospectively notify AES-PR of all filings through their legal counsel Mr. Boxerman, Mr. Mundel and Ms. Pagán.
