RESOLUTION

The Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") recently concluded the public hearings process across the Island,¹ which resulted in numerous participations from the general public. On February 11, 2020, the Energy Bureau issued a Resolution ("February 11 Resolution")² through which it modified the procedural calendar in the instant case to extend the Final Substantive and Legal Briefs and the Reply to Legal Briefs deadlines until February 28 and March 9, 2020, respectively.

However, in order to provide the parties the opportunity to evaluate all comments submitted as part of the public comments process, the Energy Bureau **MODIFIES** the procedural calendar in the instant case as detailed below.
