SUBJECT: Motion by Local Environmental
Organizations Seeking One-Week Extension
to Briefing Schedule.

RESOLUTION

On February 10, 2020, the Local Environmental Organizations filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion by Local Environmental Organizations Seeking One-Week Extension to Briefing Schedule* ("Motion"). Through its Motion, the Local Environmental Organizations state that, based on the current procedural calendar of the instant case, the Final Substantive and Legal Briefs are due on February 21, 2020 and the Reply to Legal Briefs are due on March 2, 2020. Furthermore, the Local Environmental Organizations state that the Energy Bureau scheduled additional public hearings across the Island for February 13th, 19th, 22nd and 25th.

For this reason, the Local Environmental Organizations request the Energy Bureau to provide a one-week extension to the briefing schedule. Specifically, the Local Environmental Organizations requested for the Final Substantive and Legal Briefs, and the Reply to Legal Briefs deadlines to be extended until February 28, 2020 and March 9, 2020, respectively.¹ The Local Environmental Organizations request "for one week extension to the briefing schedule: so brief would be due on February 28th after the conclusion of all public hearings, and reply brief would be March 9th." They argue "this would allow the Bureau to devote full attention to the public hearings at Mayagüez and Ponce.

Upon review of the arguments included in the Motion, the Energy Bureau **GRANTS** the Local Environmental Organizations' request for extension and **MODIFIES** the procedural calendar in the instant case as follows:
