**RESOLUTION AND ORDER**

On March 17, 2020, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") held a Technical Conference meeting via telephone with the Puerto Rico Electric Power Authority ("PREPA") to discuss PREPA's March 13 Filing<sup>1</sup> in the instant case. On March 19, 2020, PREPA filed a document titled *Motion in Partial Compliance with Bench Order and Request for Extension of Time* ("March 19 Motion"), through which PREPA submitted the Fuel Report used in support of some of the information provided in the March 13 Filing. On March 20, 2020, PREPA filed a document titled *Motion in Compliance with Bench Order and to Submit Revised Proposed Factors and Presentation* ("March 20 Motion"), through which PREPA submitted, among others, revised proposed factors for the period of April to June 2020.

In light of the above, the Energy Bureau **ORDERS** PREPA to attend a Technical Conference meeting to be held via telephone **on March 24, 2020 at 3:00 p.m.** As part of the Technical Conference, PREPA representatives shall have all pertinent documents (*i.e.*, printed and digital) readily available and be prepared to address any questions from the Energy Bureau related to the March 13 Filing, the March 19 Motion and the March 20 Motion. The Energy Bureau will provide dial-in information in a separate communication.


