RESOLUTION

On April 14, 2020, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Request for Leave to Execute Sixteenth Contract Release Number* ("Motion"). Through the Motion, PREPA provided the draft Siemens Contract Release 16 ("CR-16"), as ordered on the July 16, 2019 Resolution and Order in the instant case.¹

In the Motion, PREPA stated that the draft CR-16 includes a detailed description of the consulting services to be provided by Siemens and a specific breakdown of the total compensation per task.² PREPA also stated that the services that form part of CR-16 do not relate to the development of the proposed Integrated Resource Plan.³

Upon review of the Motion, the Energy Bureau **TAKES NOTICE** of the information submitted, and **GRANTS** PREPA leave to execute CR-16. The Energy Bureau **DETERMINES** that the tasks detailed in the Motion are necessary for operational and forecasting purposes.
