AMENDED MOTION TO SUBMIT REPLY TO FINAL BRIEFS**

TO THE HONORABLE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority through the undersigned legal representation and respectfully sets forth and pray:

1. On May 27, 2020, Instituto de Competitividad y Sostenibilidad Económica de Puerto Rico, Centro Unido de Detallistas, Cámara de Mercado, Industria y Distribución de Alimentos, Puerto Rico Manufacturers Association and Unidos por Utuado (the “Not for Profit Intervenors”) filed with the Puerto Rico Public Service Regulatory Board (the “Energy Bureau”) an *Amended Motion to Submit Reply to Final Briefs* (the “Amended Motion”).

2. The Amended Motion claims to correct the summary on pag. 7 of the *Motion to Submit Reply to Final Briefs* filed on May 26, 2020, which the Puerto Rico Electric Power Authority (PREPA) previously opposed¹.

3. PREPA moves the Energy Bureau to strike the Amended Motion from the record. Pursuant to the Energy Bureau’s Resolution and Order entered on April 15, 2020, the deadlines for all parties to submit the reply to final briefs elapsed on April 20, 2020 at 5:00pm².
