**MOTION TO SUBMIT CILT, SUBA-HH AND SUBA-NHH
RECONCILIATIONS AND PROPOSED FACTORS**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority through the undersigned legal representation and respectfully sets forth and pray:

As part of the Puerto Rico Electric Power (PREPA) Permanent Rate implementation process, the Energy Bureau of the Puerto Rico Public Service Regulatory Board (the “Energy Bureau”) approved several riders designed to recover the costs associated to fuel, power, power purchase, Contribution in Lieu of Taxes (CILT), help to human subsidies (SUBA-HH), non-help to human subsidies (SUBA-NHH) and the energy efficiency riders.¹ On April 25, 2019, the Energy Bureau entered a *Resolution and Order* in which it established the processes to reconcile and approve these riders’ factors (the “April 25 Order”).² The April 25 Order also sets the cadence for the revision of the latter, which is to be made on a yearly basis.

In compliance with the January 10 Order and the April 25 Order, PREPA herein submits the reconciliation of CILT, SUBA-HH and SUBA-NHH and the proposed factors to be applied during the next fiscal year. Exhibit A.

WHEREFORE, PREPA respectfully requests the Energy Bureau to find PREPA in compliance with the January 10 Order and the April 25 Order and approve the reconciliations and proposed factors herein submitted.
