**MOTION IN COMPLIANCE WITH ORDER
ENTERED ON JUNE 12, 2020**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority through the undersigned legal representation and respectfully sets forth and pray:

On June 5, 2020, the Puerto Rico Electric Power Authority (the “Authority”) filed *Motion to Submit CILT, SUBA-HH and SUBA-NHH Reconciliations and Proposed Factors* (the “Motion”). The Motion includes the current term reconciliations of the CILT,¹ SUBA-HH and SUBA-NHH riders and the proposed factors for the period of July 2020 through June 2021. Last Friday night of June 12, 2020, the Energy Bureau notified a *Resolution and Order* to the Authority in which it requested several documents that were not included as part of Exhibit A of the Motion (the “June 12 Order”).

In compliance with the June 12 Order, the Authority herein submits the fuel, generation and maximum demand calculation and the updated version of the annual reconciliation file. Exhibit A.

WHEREFORE, the Authority respectfully requests the Energy Bureau note the filing of the instant motion and the documents attached hereto and, to find the Authority in compliance with the June 12 Order.
