

> SUBJECT: Motion in Compliance with Order Entered on June 12, 2020; Technical



RESOLUTION AND ORDER

On June 12, 2020, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order in the instant case ("June 12 Resolution") through which it ordered the Puerto Rico Electric Power Authority ("PREPA") to file updated versions of the files "ANNUAL RECONCILIATION - CILT AND SUB RIDERS -MAY 2019 TO APRIL 2020 (Update by Planning).xlsx" and "Attachment 5 - CILT and SUBSIDIES RECONCILIATION - Filing 06052020.xlsx" filed as part of PREPA's June 5 Filing.1 The purpose of said order was for PREPA to reflect corrected calculations of the reconciliations and proposed CILT,² SUBA-HH³ and SUBA NHH⁴ rider factors that considered the Prior Period Adjustments approved by the Energy Bureau in the June 27 Resolution.⁵ Additionally, the Energy Bureau ordered the submission of the file "Proyección de consumo, generación y demanda máxima 2021-39 (updated May292020).xlsx" in original format with formulae intact. PREPA was required to provide the aforementioned documents on or before 5:00 p.m. of June 15, 2020.

On June 15, 2020, PREPA filed a document titled Motion in Compliance with Order Entered on June 12, 2020 ("June 15 Filing"). Through its Motion, PREPA submitted a revision of the file "ANNUAL RECONCILIATION - CILT AND SUB RIDERS - MAY 2019 TO APRIL 2020 (Update by Planning).xlsx" as well as the file "Proyección de consumo, generación y demanda

máxima 2021-39 (updated May292020).xlsx".⁶ However, PREPA did not include a revision of the file "Attachment 5 - CILT and SUBSIDIES RECONCILIATION - Filing 06052020.xlsx" as required in the June 12 Resolution.

In light of the above, the Energy Bureau **ORDERS** PREPA to submit, **on or before 12:00 p.m. June 22, 2020**, an updated version of the file "Attachment 5 - CILT and SUBSIDIES RECONCILIATION - Filing 06052020.xlsx" that reflect corrected calculations of the proposed CILT, SUBA-HH and SUBA NHH rider factors.

Additionally, the Energy Bureau **ORDERS** PREPA to attend a Technical Conference meeting to be held via telephone on **June 23, 2020 at 9:00 a.m.** As part of the Technical Conference, PREPA representatives shall have all pertinent documents (*i.e.*, printed and digital) readily available and shall be prepared to address questions from the Energy Bureau related to the June 5 Filing, the June 15 Filing and the June 17 Filing⁷ in the instant case. The Energy Bureau will provide dial-in information in a separate communication.
