MOTION TO INFORM REGARDING ORDER ENTERED ON JUNE 19, 2020

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority through the undersigned legal representation and respectfully sets forth and pray:

On June 5, 2020, the Puerto Rico Electric Power Authority (the "Authority") filed *Motion* to Submit CILT, SUBA-HH and SUBA-NHH Reconciliations and Proposed Factors (the "Motion"). The Motion includes the current term reconciliations of the CILT, SUBA-HH and SUBA-NHH riders and the proposed factors for the period of July 2020 through June 2021. On June 12, 2020, the Energy Bureau notified a Resolution and Order in which it requested several documents that were not included as part of Exhibit A of the Motion (the "June 12 Order").

On June 15, 2020, the Authority complied with the Order.² However, the Authority did not submit an updated "Attachment 5 – CILT and SUBSIDIES RECONCILIATION – Filing 060520.xlsx" (the "Attachment 5") as requested by the June 12 Order. The updated Attachment 5

was not included because the supporting documents requested as part of the June 12 Order did not

warrant an update of said file. The information of Attachment 5 has remained unaltered.

On June 19, 2020, the Energy Bureau entered a Resolution and Order in which it informs

that the Authority did not filed the updated Attachment 5 that reflect corrected calculations of the

proposed CILT, SUBA-HH and SUBA-NHH rider factors.³ The Authority herein informs that it

did not file an updated Attachment 5 with the June 15 Filing because the documents submitted in

compliance with the June 12 Order did not warrant an update to said file.

The Authority is available to have a short technical conference today in the afternoon to

discuss this discrete issue.

WHEREFORE, the Authority respectfully requests the Energy Bureau note the filing of

the instant motion and to find the Authority in compliance with the June 19 Order.
