**MOTION IN COMPLIANCE WITH ORDER ENTERED ON JUNE 24, 2020  
AND TO REQUEST EXTENSION OF TIME OF FIVE HOURS  
TO SUBMIT ADDITIONAL INFORMATION**

TO THE PUERTO RICO ENERGY BUREAU:

COMES NOW the Puerto Rico Electric Power Authority through the undersigned legal representation and respectfully sets forth and pray:

On June 23, 2020, the Puerto Rico Electric Power Authority (the “Authority”) appeared to a Technical Conference before the Energy Bureau of the Puerto Rico Public Service Regulatory Board (the “Energy Bureau”). During the Technical Conference, the Energy Bureau discussed several requirements for information to the Authority and later decided that said requirements were going to be included in a written resolution and order. The *Resolution and Order* was issued this morning and it directs the Authority to comply with several requirements for information and document production.<sup>1</sup> The Authority herein responds to each of the requests as listed in the June 24 Order.

1. PREPA shall file any reports and or supporting documents for the data included in tabs "Subsidios FY2019" and "Subsidios FY2020" of the file "ANNUAL RECONCILIATION - CILT AND SUB RIDERS - MAY 2019 TO APRIL 2020 (Update by Planning).xlsx", (June 15 Filing version).

2. PREPA shall file an updated version of the file "Subsidios 2021.xlsx", submitted as part of the June 5 Filing, with the following corrections:

- a. The calculation of the estimated costs of the Help-to-Humans and Non Help-to-Humans subsidies, to include the costs associated with the Special Residential Service (LRS) tariff.
- b. The formulas used for the calculation of the first and second energy blocks charge for the GSP and GST rates, on Tab "Analoga" of the aforementioned file.
- c. PREPA shall revise the cost associated with the Energy Bureau Assessment (Tab "RESUMEN"), as established by the Energy Bureau in the June 19, 2020 Resolution and Order in Case No. NEPR-MI-2020-0007.
- d. PREPA shall file updated versions of the submitted files that are affected by such corrections.

**Response:** See Exhibit A.

3. A revised calculation of the projected costs associated with Municipal Public Lighting, taking into consideration a reasonable increase in the percentage of public lights that are expected to be in service during FY20 20-2021. Such calculation must be taken into consideration in the calculation of the projected Help to Humans Subsidies costs, contained in the file "Subsidios 2021.xlsx", of the June 5 Filing.

**Response:** See Exhibit B. The Authority did not change the .50% increase of the public lighting because when the historic data was analyzed, even taking in consideration the period after Hurricane Maria, earthquakes and the COVID pandemic, the public lighting increased only by .40%. The Authority included a *tab* in the report with historic data to support the decision to maintain the .50% increase. However, the Authority did change the percentage of public lighting recuperation made by the Transmission and Distribution Directorate from .50% to .40%.

6. A revised version of the file containing revised proposed FCA, FOS and PPCA rider factors that would be in effect from July 1, 2020 to September 30, 2020. The

proposed FCA rider factor must include three scenarios: (i) zero percent (0%) deferment of possible FEMA reimbursement, (ii) seventy-five percent (75%) deferment of possible FEMA reimbursement and (iii) one hundred percent (100%) deferment of possible FEMA reimbursement. Such file must also contain a revised proposed CILTA, SUBA-HH and SUBA-NHH rider factors that will be in effect from July 1, 2020 to June 30, 2021. Such proposed rider factors should take into consideration the adjustments the Energy Bureau ordered as part of the June 12, 2020 Resolution and Order in the instant case, and the modifications instructed herein.

**Response:** See Exhibit B.

The Authority herein informs that items 4 and 5 of the June 24 Order have not been addressed in this motion. Mr. Arturo Deliz, Administrator Disaster Funds Management Office, and Mr. Nelson Morales, Chief Financial Officer, officers in charge of the FEMA and insurance matters of the Authority, respectively, are currently participating in the Authority's Governing Board meeting.<sup>2</sup> The Authority herein requests a brief extension of five (5) hours, that is until 5:00pm, to address the June 24 Order's items 4 and 5.

WHEREFORE, the Authority respectfully requests the Energy Bureau note the filing of the instant motion, to find the Authority in partial compliance with the June 24 Order and to grant until 5:00pm to address the June 24 Order's items 4 and 5.
