**RESOLUTION**


On June 23, 2020, the Energy Bureau of the Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order requiring representatives of the Puerto Rico Electric Power Authority ("PREPA") to attend a Technical Conference scheduled for June 29, 2020 at 2:00 pm ("June 23 Resolution and Order"). The Technical Conference is intended for PREPA representatives to answer Energy Bureau's questions about the report submitted on June 19, 2020 regarding the efforts made to achieve the demand response goal established by the Energy Bureau in the Resolution and Order issued on May 22, 2020 in the instant case.

On June 26, 2020, Comité Diálogo Ambiental, Inc., El Puente de Williamsburg Inc., Enlace Latino de Acción Climática, Comité Yabucoaño Pro-Calidad de Vida, Inc. Alianza Comunitaria Ambientalista del Sureste, Inc., Sierra Club and its Puerto Rico chapter, Mayagüezanos por la Salud y el Ambiente, Inc., Coalición de Organizaciones Anti-Incineración, Inc., Amigos del Río Guaynabo, Inc., Campamento Contra las Cenizas en Peñuelas, Inc., CAMBIO Puerto Rico, and Unión de Trabajadores de la Industria Eléctrica y Riego ("Petitioners") filed before the Energy Bureau a document titled *Petitioners' Motion to Request Participation at the Technical Conference Meeting* ("Motion"). Through its Motion, Petitioners stated that, on April 27, 2020<sup>1</sup>, the Energy Bureau granted them participation in the instant case. Furthermore, Petitioners argue that their attendance to the Technical Conference Meeting, scheduled for June 29, 2020, is necessary in order to continue providing information in the proceeding. Therefore, Petitioners request the Energy Bureau to provide dial-in information for the June 29, 2020 Technical Conference Meeting.


The Energy Bureau **NOTIFIES** PREPA and the Petitioners that it will timely provide to them the Technical Conference's dial-in information via email to their legal representatives. As with the previous Technical Conference held in the instant case, Petitioners' are welcome to listen to the Technical Conference Meeting; however, the Energy Bureau will not allow questions from Petitioners during the call.


