Re: Notice of International Business Machines Corporation ("IBM") as Material Front-End Subcontractor - Puerto Rico Transmission and Distribution System Operation and Maintenance Agreement (the "Agreement") among the Puerto Rico Electric Power Authority ("Owner"), Administrator, LUMA Energy, LLC ("ManagementCo") and LUMA Energy ServCo, LLC ("ServCo" and, together with ManagementCo, "Operator") dated June 22, 2020 (the "Notice").

Unless otherwise defined herein, defined terms appearing in this Notice shall have the meaning ascribed to them in the Agreement.

Pursuant to Section 4.9(a) of the Agreement, Operator hereby notifies Administrator that it intends to engage IBM as a Material Front-End Subcontractor for performance of Front-End Transition Services in excess of US \$250,000.

To help expedite matters, ManagementCo, pursuant to Section 4.9(b) of the Agreement which enables the Administrator to request information pertaining to: (i) any conflicts of interest, (ii) any record of felony criminal convictions or pending felony criminal investigations and (iii) any final judicial or administrative finding or adjudication of non-performance of contracts with Owner or Administrator, hereby provides the Administrator with information as captured below.

International Business Machines Corporation	Technology Implementations and Assessments	In respect to issues pertaining to items (i), (ii) & (iii) noted in Section 4.9 (b), on review with IBM, IBM's Vice President of IBM Global Business Services noted: "In executing the Agreement and SOWs as drafted with LUMA, I can confirm that IBM Corp would have no known conflicts of interest with, or issues of non-performance of contracts with, PREPA or the Puerto Rico Public Private Partnerships Authority. Regarding your question about criminal convictions, IBM is a large, multinational company that, as a matter of course, is a party to many lawsuits. IBM is not, however, currently a party to any lawsuit that will affect its ability to perform the services outlined in the SOWs. An explanation of the material litigation to which IBM is a party is contained in IBM's Annual Report, a copy of which is available online at http://www.ibm.com/annualreport/ . Pursuant to section 4.9(a) of the Agreement, if Administrator does not respond to Operator within ten (10) Business Days after being notified of Operator's engagement or intention to engage a Front-End Subcontractor, Administrator shall be deemed to have no objection to the engagement of such Front-End Subcontractor.
