REQUEST FOR EXTENSION TO SUBMIT COMMENTS

COME NOW DuPont Electronics Microcircuits Industries, Ltd., FMC Agricultural Caribe Industries, Ltd. Inc., and Bristol-Myers Squibb Holdings Pharma Ltd. Liability Company (hereinafter, jointly, "Commenters"), represented by the undersigned legal counsel, and very respectfully state and pray:

1. On October 19, 2020, the Energy Bureau issued a Resolution wherein it notified the publication of the Proposed Regulation for the Evaluation and Approval of Agreements Between Electric Service Companies ("Proposed Regulation") and invited comment regarding the Proposed Regulation through November 18, 2020.
2. The Commenters, who operate manufacturing plants in Puerto Rico, are interested in submitting comments to the Proposed Regulation specifically to address private agreements related to industrial projects. The Commenters intend to provide detailed feedback which they believe would be beneficial to the Honorable Bureau and other interested stakeholders.
3. However, the Commenters foresee that they will require additional time to prepare their comments. Thus, they request that an additional term of thirty (30) days be granted, that is, until December 18, 2020. We believe the time extension will be beneficial to the proceeding.

WHEREFORE, DuPont Electronics Microcircuits Industries, Ltd., FMC Agricultural Caribe Industries, Ltd. Inc., and Bristol-Myers Squibb Holdings Pharma Ltd. Liability Company request that they be granted an additional term of 30 days be granted, that is, until December 18, 2020, to submit comments to the Proposed Regulation for the Evaluation and Approval of Agreements Between Electric Service Companies.
