RESOLUTION AND ORDER

On October 6, 2020, the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") issued a Resolution and Order¹ through which it opened the instant docket for the purpose of addressing the implementation phase of the Puerto Rico Electric Power Authority ("PREPA") Approved Integrated Resource Plan ("IRP") and Modified Action Plan.²
