RESOLUTION AND ORDER

On May 8, 2020, the Puerto Rico Electric Power Authority ("PREPA") filed before the Energy Bureau of the Puerto Rico Public Service Regulatory Board ("Energy Bureau") a document titled *Motion to Withdraw the May 7 Memorandum* ("Motion to Withdraw"). As part of the Motion to Withdraw, PREPA stated that on May 7, 2020, PREPA had filed a *Memorandum of Law Requesting Confidential Treatment to Insurance Claim Communications* ("May 7 Memorandum").
