**DESIGNATION OF HEARING EXAMINER**

On September 18, 2019, the Puerto Rico Energy Bureau ("Bureau") issued a Resolution authorizing Counsel José A. Sadurní Lahens to serve as a Hearing Examiner in the Formal Bill Review Proceedings pursuant to the provisions of Regulation 8863<sup>1</sup> and in the Claims proceedings pursuant to the provisions of Regulation 8543<sup>2</sup>.
